**NOTICE OF SPECIAL RECALL ELECTION
STOCKTON UNIFIED SCHOOL DISTRICT
AT A SPECIAL ELECTION TO BE HELD
JUNE 8, 2010**

Pursuant to California Elections Code Section 11241, please be advised that the Registrar of Voters of the County San Joaquin has set the date for the Special Recall Election of Daniel Castillo, Trustee of Stockton Unified School District Area No. 7. Pending the approval of the San Joaquin County Board of Supervisors, the Special Recall Election shall be held on June 8, 2010, and shall be consolidated with the regular statewide election on that date. The purpose of the Special Recall Election is to determine whether Daniel Castillo shall be recalled from his office and to elect a successor if necessary.

Nomination papers and Declarations of Candidacy for eligible candidates to succeed the recalled officer may be obtained from the Registrar of Voters Office, located at 44 North San Joaquin Street, Suite 350 in Stockton, California. To be qualified, a candidate must be a registered voter residing in the District and in the Trustee Area.

Declarations shall be available beginning February 16, 2010, and shall be filed with the Registrar of Voters Office no later than 5:00 p.m. on March 12, 2010.

If the candidate desires to have a Candidate's Statement, that candidate shall pay a deposit at the time of filing nomination documents, pursuant to Elections Code Section 13307. Each statement shall be included in the Sample Ballot, which is mailed to each voter.
